RELEASE AND INDEMNIFICATION AGREEMENT EPIC ANGLING & ADVENTURE, LLC

Client realizes and recognizes that there are natural and man-made hazards and risks involved in any travel, particularly travel relating to or arising from fishing, hiking and related activities. Client further realizes and acknowledges that participation in such activities exposes the participant to hazards and dangers which may include among others: The use of dangerous firearms, sharp instruments and other equipment for fishing and hiking both individually and in groups; being in rugged, remote wilderness areas; exposure to severe and rapidly changing weather and elements; exposure to poisonous insects, fauna and wildlife; exposure to animals and fish capable of causing severe injury or death to the participant; exposure to disease and/or infection causing bacteria; the pursuit and catching of fish; lack of medical facilities and trained personnel in remote locations; use of public and charter transportation carriers, helicopters, large and small aircraft, large and small boats, rafts, all-terrain vehicles and other transportation methods in rugged and remote areas; rapidly changing and severe weather areas; and delays, missed connections, accommodation and travel changes due to adverse weather, strikes, equipment or other factors.

**RELEASE AND INDEMNIFICATION AGREEMENT
EPIC ANGLING & ADVENTURE, LLC**

The undersigned Client has requested the assistance/services of EPIC ANGLING & ADVENTURE, LLC for making arrangements and reservations for travel, fishing outfitting, hiking, boating, kayaking, guiding and/or other fishing and outdoor activities ("EPIC ANGLING & ADVENTURE Services"). The term "EPIC" as used in this Agreement includes EPIC ANGLING AND ADVENTURE, LLC, its officers, directors, agents, representatives and their employees. EPIC has agreed to provide such EPIC ANGLING AND ADVENTURE Services to the Client but conditioned upon Client's agreement to the terms of this Release and Indemnification Agreement as follows:

1. Client understands and agrees that there are natural and man-made hazards and risks in any travel and/or outdoor activity and Client assumes all risks in connection with any activity arranged through the EPIC ANGLING & ADVENTURE Services. Client further agrees and understands that EPIC assumes no liability for the safety of Client and/or Client's property.

2. Client hereby releases, relinquishes and discharges EPIC for any liabilities, damages, economic loss or injury to the person and/or property of Client arising from, related to or incidental to the EPIC ANGLING & ADVENTURE Services and/or activities arranged thereby and whether or not such liability, damages, economic loss or injury are caused by the negligence of EPIC, whether it be sole, joint, concurrent, active or passive negligence. Such release shall specifically include all minor children listed below.

3. CUMULATIVE OF THE FOREGOING, CLIENT AGREES TO INDEMNIFY AND HOLD EPIC HARMLESS FROM ANY AND ALL ACTIONS OR CAUSES OF ACTION, CLAIMS, DEMANDS, LIABILITIES, LOSS, DAMAGE, INJURY, COST OR EXPENSE OF WHATEVER KIND OR NATURE, INCLUDING COSTS OF LITIGATION, ATTORNEYS' FEES AND REASONABLE EXPENSES IN CONNECTION THEREWITH FOR INJURY TO CLIENT OR ANY MINOR CHILDREN LISTED BELOW AND/OR FOR ECONOMIC LOSS AND/OR FOR DAMAGE TO OR LOSS OF PROPERTY RELATING TO OR ARISING FROM THE EPIC ANGLING & ADVENTURE SERVICES.

4. CLIENT EXPRESSLY CONFIRMS THAT IT IS THE INTENT OF CLIENT TO INDEMNIFY EPIC TO THE MAXIMUM EXTENT ALLOWED BY LAW AND THAT ALL INDEMNITY OBLIGATIONS AND LIABILITIES ASSUMED BY CLIENT UNDER THE TERMS HEREOF SHALL BE WITHOUT MONETARY LIMIT AND THAT BY EXECUTING THIS AGREEMENT, CLIENT EXPRESSLY AGREES TO RELEASE AND INDEMNIFY EPIC FROM AND AGAINST THE CONSEQUENCES OF EPIC'S OWN NEGLIGENCE (WHETHER SUCH NEGLIGENCE IS ACTIVE OR PASSIVE AND WHETHER SUCH NEGLIGENCE IS THE SOLE PROXIMATE CAUSE OR A PROXIMATE CAUSE JOINTLY AND CONCURRENTLY WITH THE NEGLIGENCE OF CLIENT OR OTHERS) RESULTING IN LIABILITY, ECONOMIC LOSS, DAMAGES OR INJURY TO THE PERSON AND/OR PROPERTY OF CLIENT (AND/OR THE MINOR CHILDREN) COVERED BY THIS AGREEMENT, THIS RELEASE AND INDEMNIFICATION AGREEMENT SHALL BE CONSTRUED FAIRLY AND REASONABLY AND NEITHERMORE STRONGLY FOR NOR AGAINST EITHER PARTY.

5. The term "injury" as used herein also covers death, and this Agreement is binding upon the estate of the Client. In addition to other matters covered hereby, the indemnification provisions of this Agreement also cover all claims for wrongful death under Section 71.001 et seq. of the Texas Civil Practice and Remedies Code.
