

**2021 COVID-19 CLIENT TRAVEL PLAN AND ACKNOWLEDGEMENT**  
**For Alaska Wilderness SAFARI and Alaska Wilderness OUTPOST guests**

I understand that...

1. **I must arrive at camp with proof of a negative molecular-based Covid-19 test taken within 72 hours of starting my travel to Alaska or within 96 hours of arriving either camp if you are already vacationing in Alaska prior to your EPIC trip, EVEN IF I HAVE BEEN VACCINATED.**
2. If I arrive camp without a negative test result, I will be isolated until I can be transported back to King Salmon, AK on my own private charter at my expense.
3. If I arrive camp with, or develop while at camp, any of the following symptoms I will be isolated and may be transported back to King Salmon, AK on my own private charter at my expense.
  - a. Fever at or above 100.4°, symptoms of fever (chills, aches & pains etc.), cough, difficulty breathing, shortness of breath, loss of smell or taste, sore throat, unusual fatigue, symptoms of acute respiratory illness
  - b. Rapid tests may be available at camp. A negative result may allow you to remain at camp.
4. I may return to camp at my own expense for the remainder of my week after receiving a negative molecular test result in King Salmon, AK, or at the direction of a medical professional.
5. **I should consider being fully vaccinated prior to my trip.**
  - a. Per the CDC, fully vaccinated people are less likely to transmit Covid-19 to others.
6. Other people on my trip may not be vaccinated.
7. I should talk with my Doctor about prescribing medications to bring on my remote trip to reduce the severity of Covid-19 symptoms and complications until I can reach definitive medical care.
  - a. Evacuation flight delays are very possible during severe or inclement weather.
8. EPIC's camps are not equipped to provide definitive medical care.
9. ~~Per State of Alaska guidance, I am advised to complete a Travel Declaration Form and Self Isolation Plan in the Alaska Travel Portal at~~ Stay up to date with AK travel info, <https://covid19.alaska.gov/travelers/>.
10. If I cancel my current 2021 trip, before my payments are forfeited I have the option to defer my trip to the week of 9/18 – 9/25, 2021 at the SAFARI camp. There may be a trip price adjustment, up or down, depending on a couple of factors.
  - a. EPIC is keeping this weekly intentionally lightly booked to give guests a trip deferment option in 2021.
11. If anyone brings Covid-19 to either operation during a week prior to my trip, it is possible that EPIC quarantines its entire staff and ceases operations for up to 14 days. Should this occur and affect my 2021 trip, my trip and payments will be deferred to 2022 or refunded.
12. I should review EPIC's 2021 Covid-19 Action Plan at <https://epicanglingadventure.com/covid/>.
13. My temperature will be taken and I will be monitored for Covid-19 symptoms each morning.
14. Face coverings are mandatory inside aircraft, dining tents at either camp (except when eating or drinking), and the dry tent at SAFARI camp.
15. I will bring my own face coverings, along with several backups.
16. I must inform EPIC if I develop any Covid-19 like symptoms within 48 hours of my trip completion, or I test positive for Covid-19 within 10 days after trip completion.
