

## 2023 COVID-19 GUEST TRAVEL PLAN AND ACKNOWLEDGEMENT

For Alaska Wilderness SAFARI and Alaska Wilderness OUTPOST quests

I understand that...

- 1. Until further notice I must arrive at camp with proof of a negative <u>viral Covid-19 test</u> taken within 48 hours of starting my air travel to Alaska or within 48 hours of arriving either camp if you are already vacationing in Alaska prior to your EPIC trip, <u>EVEN IF I AM FULLY VACCINATED.</u>
  - a. Laboratory or Rapid Point-of-Care viral tests are preferred to ensure quality of testing. Self-tests (home tests) may be used as a backup, as long as it is a viral test and as long as the instructions are strictly followed.
- 2. I am required to bring a copy of my test result with me to camp.
- 3. If I arrive camp without a negative test result, I may be isolated until I can be transported back to King Salmon, AK on my own private charter at my expense.
- 4. If I arrive camp with, or develop while at camp, any of the following symptoms I may be isolated and may be transported back to King Salmon, AK on my own private charter **at my expense**.
  - a. Fever at or above 100.4°, symptoms of fever (chills, aches & pains etc.), cough, difficulty breathing, shortness of breath, loss of smell or taste, sore throat, unusual fatigue, symptoms of acute respiratory illness
  - b. Rapid tests will be available at camp. A negative result may allow you to remain at camp.
- 5. If #3 or #4 above occurs, I may return to camp **at my expense** for the remainder of my week after receiving a negative viral test result in King Salmon, AK, or at the direction of a medical professional.
- 6. Other people on my trip may not be fully vaccinated.
- 7. I should talk with my doctor about prescribing medications to bring on my remote trip to reduce the severity of Covid-19 symptoms and complications until I can reach definitive medical care.
  - a. Evacuation flight delays are very possible during severe or inclement weather.
- 8. EPIC's remote camps are not equipped to provide definitive medical care.
- 9. If I cancel my 2023 trip, before my payments are forfeited I have the option to defer my trip to other open dates within the 2023 season. There may be a trip price adjustment, up or down, depending on a couple of factors too long to explain here.
- 10. If anyone brings Covid-19 to either operation during a week prior to my trip, although very unlikely, it is possible that EPIC quarantines its entire staff and ceases operations for several days. Should this occur and adversely affect my 2023 trip, my trip payments will be deferred to 2024 or refunded.

11. I will be responsible for informing camp staff if I am feeling ill while on my trip
